Cornell House: 2934 Bristol Road

Discussions with owner regarding preservation Exploring funding resources for preservation

Illg Farm: 365 Folly Road

House and two barns
Unable to preserve house or barns
Recovered minor artifacts from English stone barn

Lazalere House: 3502 Limekiln Pike

House and barn

Discussions with owner regarding preservation

Currently no incentive to preserve house or barn

No-impact reviews:

Reviewed multiple proposed developments, site modifications and other permit submissions which were determined to have no historical impact

Ongoing concerns:

Murphy tract: 2934 Bristol Road

Proposed development threatens historic house Advocate preservation of house, salvage of barns

Mill Creek School: vintage school house

Concern for maintaining historic façade

Current offices of Warrington Tax Collector; anticipated new tenant

Agreement to preserve, to extent possible, historic aspects of building

Eble House:

Meticulously restored house and outbuildings

Offered preservation easement in 2016 – not accepted by BOS

Still potential for renewed discussions

Kulp House: 2616 County Line Road

Unmodified 1800 house

Very poor repair, little interest from owner in preservation

Would be endangered by County Line Road widening

Arnold House: 2401 County Line Road

Excellent example of early Bucks County farm house architecture

Excellent condition; well maintained

Endangered: in right-of-way of County Line Road and Bradford Road

Barclay School

Presentation on Warrington history to about 75 second graders Helped them celebrate John Barclay's 268th birthday
